**IMPORTANT ELIGIBILITY REQUIREMENTS**

**Please ensure you meet the following criteria before applying:**

**General Eligibility**

- Only subscribing members are eligible for election via the elected route
- Elected route candidates must have been a club member entitled to vote for at least two calendar years by 31 October prior to the AGM
- Non-members applying via the nominated route must become members if successful

**Employment Restrictions**

- Current club employees or employees of club-controlled bodies cannot serve on the General Committee
- Former employees must wait three years after leaving employment before being eligible

**Proposer/Seconder Requirements**

- Proposers and seconders must be subscribing members entitled to vote
- Required only for elected route applications

**Selection Process**

- All applicants will be interviewed by the Nominations Panel to assess eligibility and suitability
- Applications may not be progressed if candidates are deemed ineligible or unsuitable
- Candidates may apply via both routes if eligible for the elected route
